The objects of the Bill are as follows:

"To constitute and incorporate a joint water board (hereinafter referred to as "the Board") comprising representatives of the Stroud Rural District Council, the Stroud Urban District Council and the Nailsworth Urban District Council and to transfer to the Board the water undertakings of the Stroud Urban District Council and the Stroud Rural District Council; to provide for the transfer to the Board of the undertaking of the Stroud Water Company and to confirm with or without amendment an agreement for the transfer to the Board or to the Stroud Rural District Council or the transfer to the Board or to the Stroud Rural District Council of the undertaking of the said Water Company.

To confer upon the Board all neces-

To confer upon the Board all necessary powers for the development maintenance and management of the undertakings transferred to them and for the supply of water within their proposed limits of supply including the urban district of Stroud, the rural district of Stroud, the urban district of Nailsworth, the parishes of Eastington and Frocester in the rural district of Gloucester, and the parish of Avening in the rural district of Tetbury. Tetbury.

To prescribe the maximum rates and charges in respect of the supply of water by the Board.

To empower the Board to make and maintain waterworks and to acquire lands and to confer upon them all necessary powers in connection therewith.

To confer all necessary powers on the Board for the purpose of carrying the proposed provisions into effect including the power to borrow money, to issue stock and to empower the constituent authorities to lend moneys to the Board and to borrow money for that purpose.

To confer further powers upon the Stroud Rural District Council in reference to the good rule and government of their district including provisions relating to buildings, drains, food, sanitary matters and finance; and other purposes."
