

# FISHER family

The FISHER family had bought The Castle from the Arundells generations before, and had gradually bought up bits and pieces of the hillside below. Other FISHERs lived locally too

But it was local solicitor Paul Hawkins FISHER who lived at The Castle in the 1850s and wrote regular columns for the local newspaper. His columns were later published as *Notes and Recollections of Stroud*, and contain much that has been useful in this research. He died on 6<sup>th</sup> October 1873 and left an estate described as “under £30,000”. His Executors were his two sons: Charles Hawkins FISHER and the Revd Frederic Colborne FISHER of Walton-on-Trent. They were also the executors for their uncle Joseph Timbrel FISHER when he died in 1869 (with an estate of “under £20,000”).

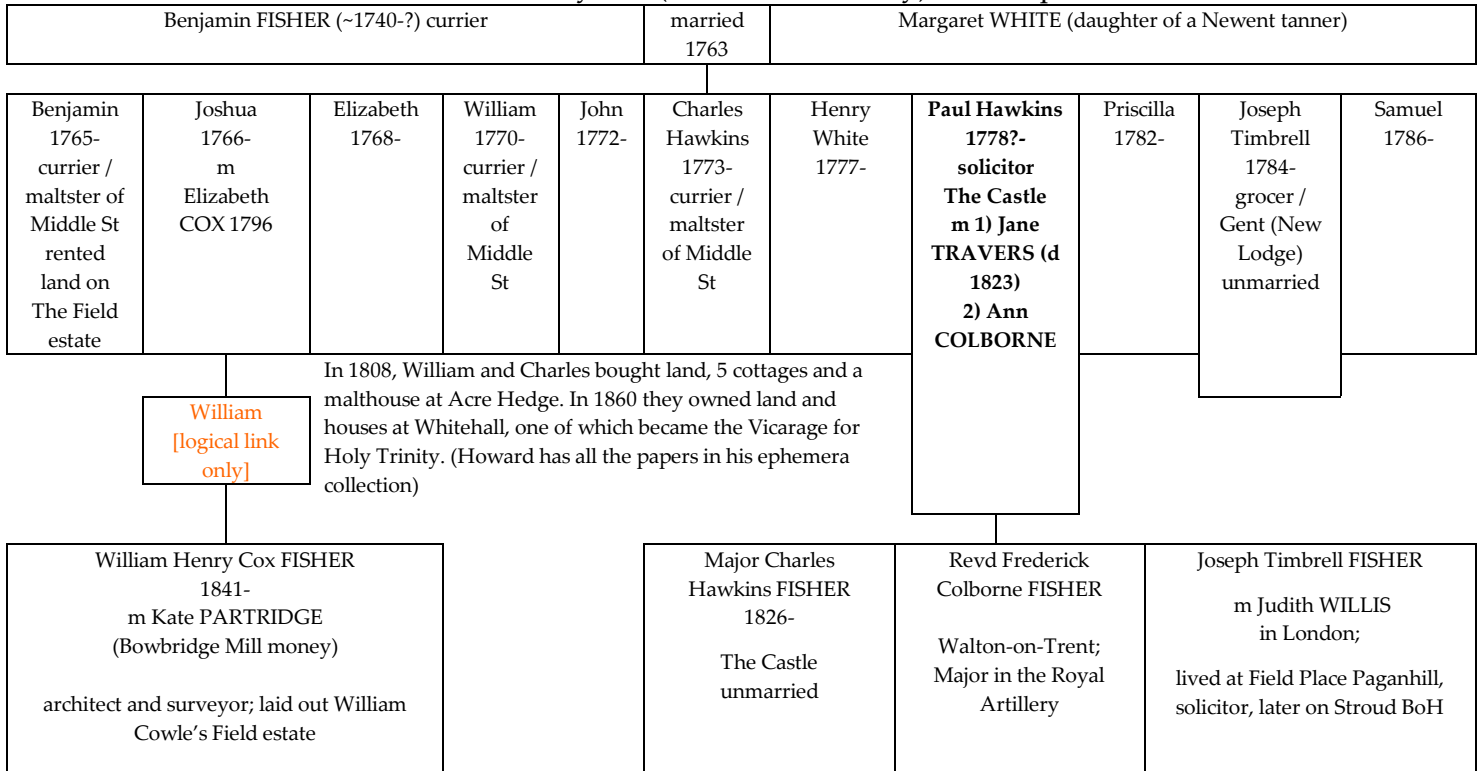
The Introduction to the 1986 edition of *Notes and Recollections* gives a fairly detailed summary of Paul Hawkins FISHER’s immediate family. This was my starting point to find out who was who. There seem to be different strands of FISHERs in Stroud. Not sure yet how they join up. Below is a list of what we have found whilst researching the FEWC.

THERE ARE STILL THESE LOOSE ENDS:

1. Is there a connection between architect William Henry Cox FISHER b 1841 to father William [parents not traceable without the original Glos St Nicholas bapt register], and Elizabeth COX wife of Inchbrook’s Joshua FISHER married 1796?
2. Still have not been able to find a TIMBRELL link – apart from the Mr TIMBRELL who donated WmC’s scrapbook to the MiP in the 1950s. He was a local man but Lionel Walrond – who accepted the donation – does not know of any link to the FISHER family – the donor married a girl from Horsley just before WW2. IGI has TIMBRELLs in Charlton Kings, and Frampton Cotterell, none in Gloucester or Stroud. Ancestry has family trees in Wiltshire.

### Benjamin FISHER ~1740-

PHF's father Benjamin is described as a currier in the Introduction to Paul Hawkins FISHER's *Notes and Recollections*. ? son Benjamin, or ?him mentioned in 1842 Abstract as a 1795 tenant of The Field estate

1763 married Margaret WHITE dau of a Newent tanner; settled in Gloucester (see *Notes&Recoll* Intro). Stroud Baptism register 05479-1 has these bapts by Benjamin and Margaret FISHER, said to have had 11 children:

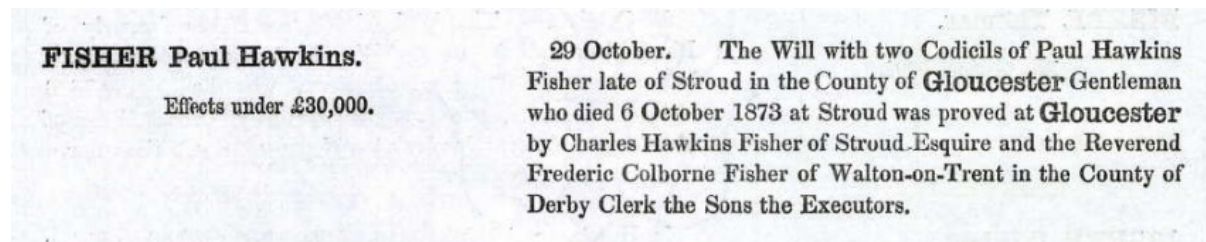
- 1) 1765 26 Feb **Benjamin**, currier; malthouse owner 1811; too many Benjs to determine death date
- 2) 1766 15 Aug **Joshua** - married Elizabeth **COX** 18 Jun 1796. Joshua died 1845Q4. He is in the Inchbrook 1841 census aged 70, Indep means, with Sarah (*who?*), Harriet and Mary.
  - a) Children of Joshua and Elizabeth (according to IGI) were:
  - b) Harriet 17 Aug 1796 Haresfield
  - c) Benjamin bap 1 Nov 1797 Painswick
  - d) Simon Peter 30 Jan 1799 Glos St Nicholas
  - e) Mary 14 Apl 1800 Glos St Nicholas
  - f) 1801 GAP – was this William, father of architect William Henry **Cox** FISHER? who in 1851 said he was bap Glos St Nicholas? His age fits, and the gap fits.

- 3) 1768 10 Mar **Elizabeth**
- 4) 1770 28 Feb **William**, currier, maltster in 1830 with bro Chas; see p3 for 1808 purchase of malthouse with bro Chas
- 5) 1772 19 Feb **John** [*not anywhere in 1841 census*]
- 6) 1773 25 Dec **Charles Hawkins**, currier, maltster in 1830 with bro Wm. see p3 for 1808 purchase of malthouse with bro Chas. In 1826 grocer Joseph FISHER borrowed £100 from Isaac SKINNER in trust for Chas. *Same Chas?*
- 7) 1777 18 Mar **Henry White** [*mmn WHITE*]
- 8) **Paul Hawkins NOT SHOWN IN REGISTER – no separate entry on IGI or Ancestry but see PHF note 5 below – maybe bap at Newent?**
- 9) 1782 21 Mar **Priscilla**
- 10) 1784 27 Dec **Joseph Timbrell** (see separate note – *Apl 2013: OldGlosDiary 7 Jan 1865 reports death of Rev John TIMBRELL, archdeacon of Gloucester, at Beckford, aged ?96 IS THERE ANY LINK?*)
- 11) 1786 26 Oct **Samuel** (later in partnership with PHF) died 22 May 1861. Probate (estate <£20,000) granted to Paul Hawkins F and Joseph Timbrel F “the Brothers and the Exors”



## FISHER family

### Paul Hawkins FISHER 1778?-1873 married with children

1. Wrote *Notes & Recollections* of Stroud pub 1873.
2. The subject of a very incomplete family tree on Ancestry (Mar 2012) that shows only one son and no parents.
3. Solicitor/attorney; lots of entries in local directories elsewhere in this archive
4. married 1) Jane (Janet) TRAVERS Middx who died 1823; 2) Ann COLBORNE
5. described in Intro to *Notes and Recollections* as "seventh son of Benjamin, currier, attended College School (Gloucester Cathedral) then attorney in Stroud" *but who wrote the Intro? and what was their source?*
6. Probate record – index says he died 6<sup>th</sup> October 1873, executors were **sons Charles Hawkins FISHER and the Revd Frederic Colborne FISHER** of Walton-on-Thames:



### Joseph Timbrell FISHER Snr 1784-1865 unmarried

1. Many appearances in the FEWC archives – key one is his ownership of New Lodge, later The Chestnuts – built on land ?bought from JCCBPH or maybe an earlier ARUNDELL (*waiting to meet with Ian Mackintosh in May 2012 – he probably has more info but busy right now with an upcoming exhibition – NO he did not have anything new – in fact we have more than he does*) Full story elsewhere in the archive.
2. 1830 Pigot shows him as Gent, Mount Pleasant. Think this is probably The Chestnuts.
3. A Joseph T FISHER had died in 1865 *no probate index entry, surprisingly*
4. in 1861 he was the last entry for Bisley Old Road (which ought to be The Chestnuts, which he had bought/built in the 1820s), a 'landed proprietor' – but **unmarried!** It seems he left some property to his eponymous nephew (see separate entry).

### William and Charles FISHER 1808++ property transactions

*Notes made from deeds found in Howard Beard's banana box of Stroud ephemera (and returned to him) plus some title deeds from Glos Arch. This is not really relevant to the FEWC but I record the names here just to have them all in one place.*

MH Feb 2013

1808 8<sup>th</sup> May a Feoffment of premises at Stroud by James LAMBURN, maltster, and others, to William and Chas FISHER curriers, who [seem to have] paid £460 for two cottages, two stables and a yard at Acre Hedge [which Tony says Paul Hawkins FISHER says is the land on the uphill side of Acre Street]

*If they were curriers, they were about the right age to be two sons of Benjamin. And either he or his eldest son Benjamin could have been the a currier renting Stroud Fields in 1795.*

However, the Foot of Fine that is filed inside the same indenture and described as the final agreement in the Court of our Sovereign Lord the King dated 'the morrow of the Holy Trinity in the 49<sup>th</sup> year of the reign of George III' lists:

5 messuages, 4 cottages, one malthouse, four gardens

## FISHER family

The solicitor for the LAMBURN partners was Samuel FISHER *[another brother? – PHF was later in partnership with bro Samuel]*. All receipted, signed and sealed 8<sup>th</sup> Oct 1808.

**1826** 7<sup>th</sup> Jan: A £100 loan by Isaac SKINNER, mason, to Joseph FISHER grocer in trust for Charles FISHER, maltster. Security offered was seven cottages, and arable land and quarry ground at Strouds Hill 130' x 70'. The full area was 3 acres but some of it had now been sold to Thomas TYLER by William WATKINS.

**1841** census: William (70) and Charles (60) FISHER, both of independent means, were living in Middle Street. *Two bachelor brothers?*

**1848** Will of Charles FISHER, gent, of Stroud, bequeathed £3,000 to his trustees Paul Hawkins FISHER, Joseph Timbrell FISHER, Charles Hawkins FISHER *[his three brothers?]* and Frederick Colborne FISHER for investment. The interest on £1,500 of that was to be paid to Eliza wife of William HAZLE of Bisley, Maltster.

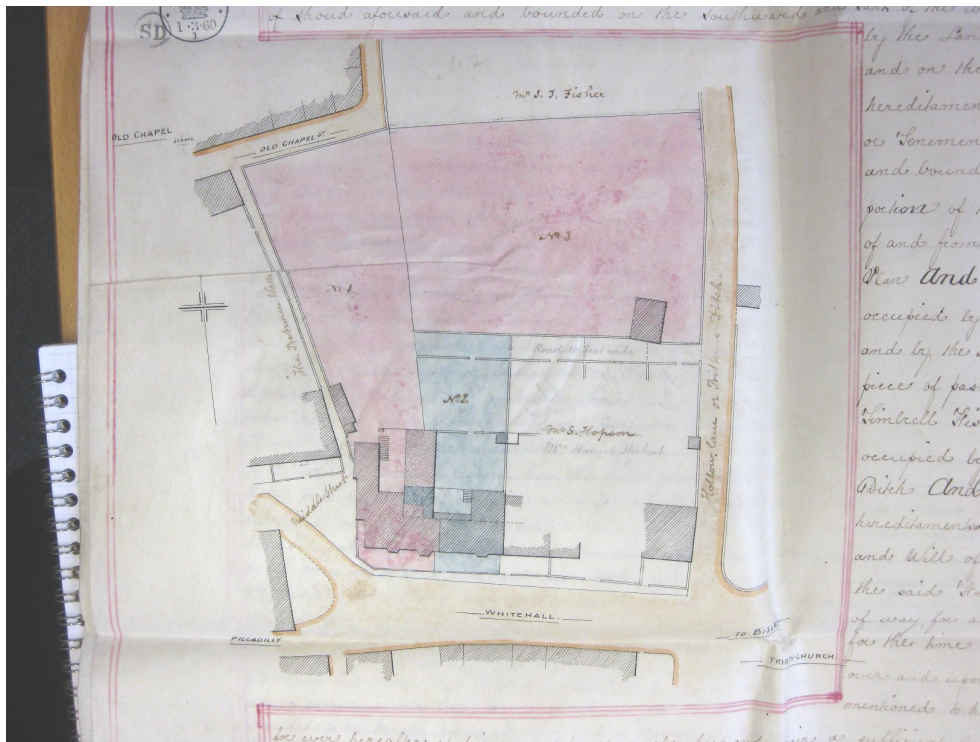

### Charles Hawkins FISHER *Jnr* 1826- son of PHF

1. Son of Paul Hawkins Fisher; owned land at The Castle and the plot on Field Road on the right just before the bend.
2. He wrote a book that I have just found on Abe Books – price £295!:  
*REMINISCENCES OF A FALCONER.* by Major Charles Hawkins Fisher of The Castle, Stroud, Gloster.  
Book Description: 1901 1<sup>st</sup> edition. John C. Nimmo. London., 1901. Pp xiv, 188. Photogravure plates. Green pictorial cloth gilt, teg. Newly recased in original cloth. New end-papers. Very good. "With seven photogravure plates and six portraits." 3. **May 2013:** Charles Fisher was a founding member of the Sherborne Lodge of Freemasons in Stroud and a contemporary of William Cowle. He lived at The Castle and sold William the corner of land that enabled Field Road to join the turnpike at a convenient angle for carriages. We have copies of the conveyances [see Section 000F2 Prelims] that transferred land between him, William, and Richard JACKSON and enabled the building of Field Road to be completed.
4. When preparing slideshows for The Cowle Legacy exhibition, I was delighted to find two more mentions of Charles Hawkins Fisher. The first was a hit is on the Royal Leamington Spa Archery

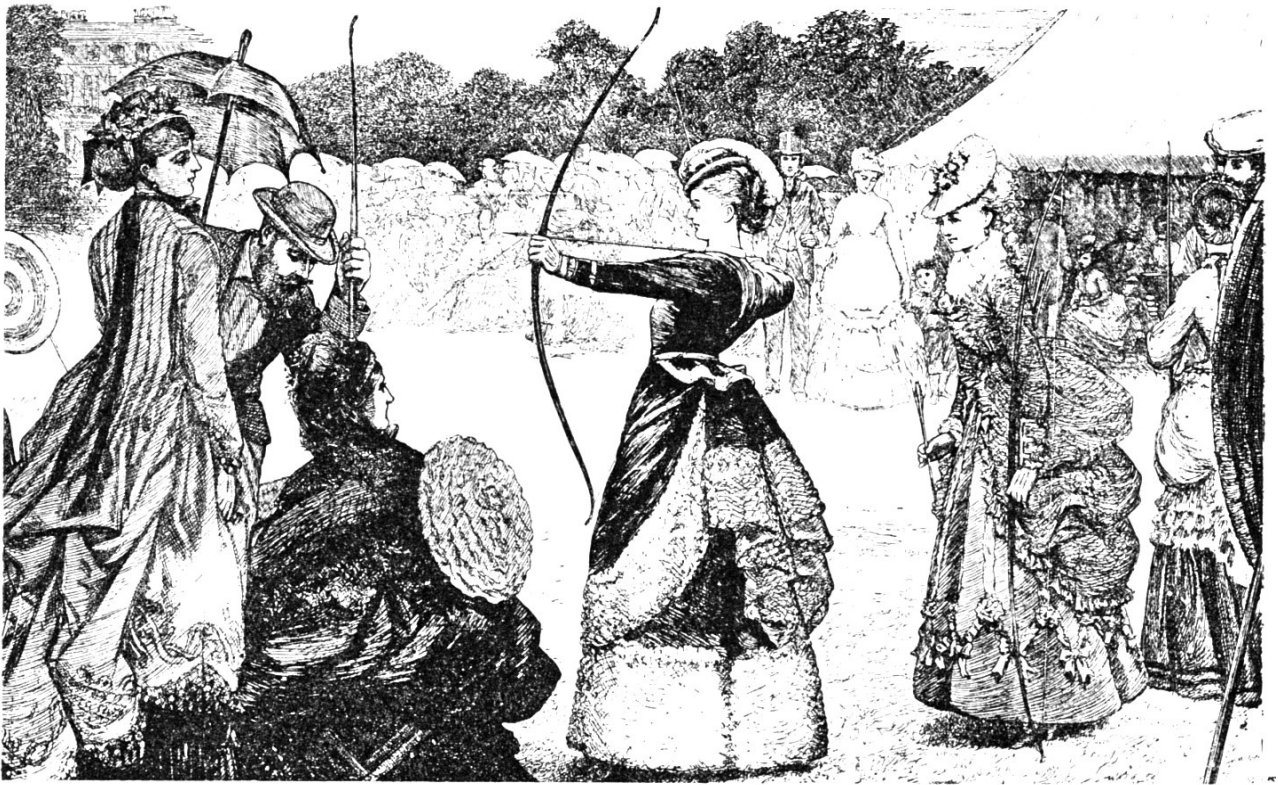
Society's website – a photograph, and a story, reproduced here with their kind consent:

“Major Charles Hawkins Fisher was one of the best archers of the late 19th century. In 1885 a cup was purchased with money donated by tradesmen and residents of Leamington. It was to be competed for by the gentlemen and retained by anyone who won it three years running. Major Fisher won it in each of the first three years, so another trophy had to be found. However, in 1891 he presented it back to the tournament, to be competed for annually in open competition. Although the original "Fisher Cup" went missing in 1933, a replacement was found and has been awarded ever since.”



5. The second find was a mention in a book called *Our Fathers* by W G Bott, published by Heinemann in 1931. I contacted them to ask if I could use the illustration and they said yes:

THE GRAND NATIONAL ARCHERY MEETING AT LEAMINGTON. “The shooting at the Shrublands was unusually good and we may note that Mrs. Horniblow was the champion, while Mr. Fisher headed the gentlemen. We have depicted the ‘Rose Queen of the Garden of Girls’ taking aim. Whatever execution she did with her arrows, she must have done far more with her eyes”

### Joseph Timbrell FISHER Jnr son of PHF

Turned up unexpectedly (Aug 2012) in the title deeds of 35 Bisley Road (see 068-35 House History), transferring Bisley Road property on 30<sup>th</sup> July 1877 to his daughter Julia Ann on her marriage to Charles Edward THORNHILL [marriage registered Stroud 1877Q3].

Joseph Timbrell FISHER was bapt on 15 Jan 1829 by his parents Paul Hawkins FISHER and Anne.

Aha – so the other Joseph T was his uncle. Good.

Family (from census returns; have not yet checked their actual DoBs)

- wife Julia (nee WILLIS m as Judith 1849Q4 Marylebone), at Field Place Paganhill in 1861 (or Judith 49 in 1881, at Lower Grange, off Folly Lane)
- children: Julia A (10 in 1861), Joseph T (9 in 1861) but he died as a boy, Frederick S (7 in 1861), Walter H (5 in 1861), Alfred C (3 in 1861), Emily M (4 in 1861), John Charles (1 in 1861), Octavius S (18 in 1881), Caroline E (14 in 1881), Reginald W (xx in 1881)

### William Henry Cox FISHER 1841-1903

#### architect of 23 and 25 Bisley Road? – Lot 66

*The author of the monograph on the Sherborne Lodge says categorically there was no family connection between WHC Fisher and Chas H Fisher Jnr. I'm not so sure. MH Feb 2013*

1841 Birth registered in Stroud Q2. No matching match on birth registers online at FamilySearch (though quite a few Wm Fishers)

Census shows father was **William FISHER, grocer** employing six men in High Street, 1851. *SO WHO WAS HIS FATHER? Nothing on IGI so need to see the original Gloucester St Nicholas Bapt Register to get his parents. IN THE MEANTIME, Joshua FISHER's wife was Elizabeth COX – is this how Wm Hy Cox FISHER get his name? I am going to stop. MH 28Feb 2013 Apl 2013: NO it isn't. Joshua+Elizabeth COX had 7 children but none called William: Harriet 1796, Benjamin '97, Simon Peter '99, Mary 1800, Jane '02, Louisa '03, Ralph '05.*

**1881 census** – at 1 Elton Villas, Slad Road - this has to be him. - Two doors away from Police Superintendent William Hanbridge, whose son Samuel bought our house (No 37 Bisley Road) in 1920.

**1884** Tony Macer thinks it is very likely that Berkshire and Devonshire Villas on Bowbridge Lane, built in 1884 for William Cowle, were designed by WHC FISHER – simply because they are so similar in architectural style (externally) to Rock Villa on Bisley Road (see next entry).

**1891 and 1901** censuses: the two houses on Lot 66 were called Belsize Villa and Rock Villa, and Rock Villa (still the name on No 25 in 2011) was the home of William Henry FISHER. When did the houses actually go up? They appear on the **1882 OS** map but can't be identified for sure in the 1881 census. Did he build these first, then Berkshire/Devonshire?

**1891** William had a wife Kate and a maid, and was living in Rock Villa. He was still there in 1901 and his unmarried sister-in-law was staying too so we now know that Kate's maiden name was PARTRIDGE. Although all three were born in Stroud, the marriage was registered in West Derby (Liverpool) in 1882 Q3 - wonder why? I went to look for Kate Selina PARTRIDGE in the 1881 census and she was at home at Oxford Villa, Cainscross with her mother and sister (so not swanning about in Liverpool then). Mother was a widow (b Uley) with an independent income from - the census says - "Bank Shares and Dyehouse Rent at Bowbridge". The 1887 map above shows Arundell Mill as a dyehouse. Now *that's* interesting. The PARTRIDGE family owned Bowbridge Mill and a couple of large houses at the southern end of Bowbridge Lane, as well as the British Oak at some point.

I also think I have seen somewhere that WHC Fisher designed the Trinity Rooms opposite the church, in Field Road. I wonder why William COWLE didn't ask him to design Park House?

WHCF was one of the executors of WmC's will and estate. It was his doing that invested WmC's museum money in the Lansdown development that had stalled for lack of funds, thereby ensuring that his friend's wish for a Science Museum was fulfilled. (there is much more about this in our book).

WHC FISHER died 1903Q2.

**FISHER** William Henry Cox of Rock-villa Bisley-road Stroud Gloucestershire civil-engineer and architect died 19 May 1903 Probate Gloucester 29 June to Kate Selina Fisher widow Effects £4240 5s. 11d.
